<u>DEPOSIT</u>	\$2,500 minimum deposit, <u>payable to Fralin & Waldron, Inc./ dba Waldron Homes</u> – on speculation homes – homes selected by the Builder for a particular lot. Five percent (5%) of the total purchase is <u>payable to Fralin & Waldron, Inc. / dba Waldron Homes</u> for custom selection jobs – homes that the buyer chooses the lot and plan to be built. The plan must be selected from Builder's portfolio of plans for Wisteria Place . All changes from builder's standards and all options require additional non-refundable deposit, which must be received prior to ordering.
